Housing for students is available at the hotel Karwendel, a comfortable dormitory-style facility within 15 minute walk or five minute tram or bus ride of the University and the Old Town.

The Karwendel offers single, twin and some triple rooms for the summer program. All rooms are non-smoking and include a private bath, sink, toilet and shower. Also a desk, chair and a single bed per person. Buffet breakfast is provided daily, including weekends. Coin-operated washers and dryers (3) are located in the basement. Bed linens and towels are changed weekly. There is a café, usually open Monday-Wednesday nights, for casual dining and drinks. The lobby level is equipped for wireless reception. Each sleeping room has one plug for an ethernet cord; the cords are for rent at the front desk if needed.

Reservations will be accepted until Tuesday, March 31, 2020 or until our room allotment is filled, whichever is first. Please note that the single rooms always sell out first. The accommodation cost for 34 nights inclusive of daily continental breakfast, weekly linen changes and current taxes are:
