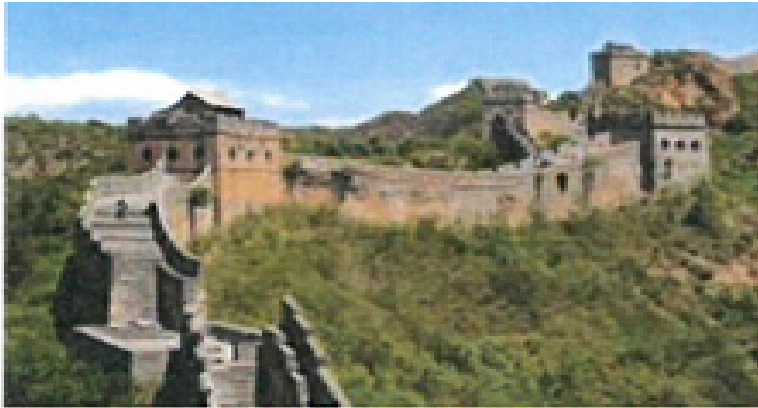


**"China Pioneer Fund Scholarship"
In Honor of Dean Charles Cantu**



Financial Assistance is available through a fund named after Dean Charles Cantu. Dean Cantu established this international program "Doing Business and Law in China."

Criteria and eligibility (China applicants):

- a. Applicant must be a St. Mary's Law student.
- b. Applicant must demonstrate academic integrity.
- c. Applicant must be involved in Pro Bono, community service, or Law Ministry.
- d. Applicant must show leadership skills in student organizations.
- e. Applicant must use scholarship funds to attend the Summer 2019 China Program.
- f. Applicant must assist in fundraising efforts and advertise the China program to future participants.

General Instructions:

1. DEADLINE for scholarship applications is **March 20, 2019, 5:00 p.m.** (no exceptions).
2. You will be notified by email regarding the status of your application.
3. Award winners will be announced by April 2019.

Application Process:

Applicant must submit the following items:

1. Completed application form and resume.
2. Letter of application addressed to the Scholarship Committee. Please include your name, email, address, class year, student ID and phone number on an attached coversheet.
3. Submit your responses to the questions referenced in application. These questions must be at least 1-2 pages, typed, and double-spaced. Please ensure your questions contains no grammatical errors.

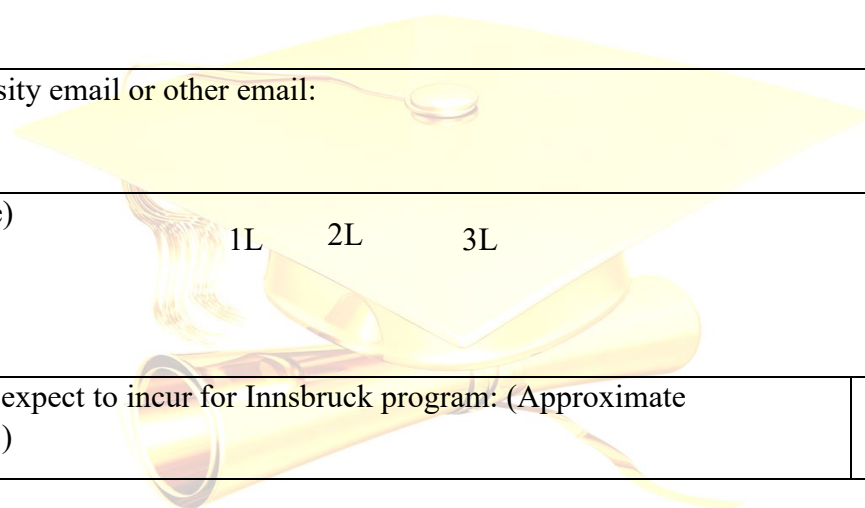
